Thank you for your concern re: the electric. We are looking into the electric situation all around and coming up with some long awaited answers. Our contractor was at the cove today and will address the actual cable issues with us as soon as possible.

As an update, we want you to know that the new catwalk we have ordered for WMA is being fabricated and is on the list for installation. Next, on our list will be addressing reparation of the roof.

Please note: WMA will again remove the skull & crossbones sign that was placed in front of the marina and reads: "Danger. Marina Closed for Repairs. Keep Out." As per March 25th email notice, repairs have been taken care of. Our marina is not, and never has been, closed. Not only do we believe it's not in the POA's jurisdiction to condemn a neighboring private property but the sign is misleading and interferes with marina business. WMA will again leave the sign by the side of the gate for your retrieval and expect that it will not be re-erected.
